With reference to above you are permitted for **two year** for manufacturing of valves up to **300 NB X 2500 # cast valves & 50 NB X 2500 # forged valves** under inspection of I.B.R.-1950 subject to the following conditions.

1. Drawings of above items must be got approved before starting manufacturing where ever required.
2. Casting / forging must be obtained or inspected under IBR -1950 from well known / approved foundry/ forger.
3. All the material must be offered for inspection along with material test certificates before use wherever applicable.

4. Before starting machining casting / forging must be offered for inspection if applicable.
5. Valves must be offered for stage wise inspection during manufacturing as per instruction of the Inspectorate.
6. All the work should be carried out strictly in accordance with Indian Boilers Regulation-1950 to the satisfaction of the Inspecting Officer and Inspecting Authority.
7. You shall have to carryout manufacturing of above items as per the instruction issued from time to time either by Inspecting Officer or by Inspecting Authority.
8. Welders must be qualified in appropriate material as per requirement of Chapter-I & XIII of Indian Boiler Regulation-1950 before starting the job in same material.
9. Items must be offered for stage wise inspection during manufacturing as per instruction of the Inspectorate wherever applicable
10. You will have to inform this office immediately if there is any change in existing name of the company /existing proprietorship / existing technical staff of the company.
11. This permission can be withdrawn at any time without giving notice if the workmanship /quality is found unsatisfactory.
12. **You are hereby instructed to get it renewed before 60 days from the expiry of this certificate.**
